In response to the harsh economic impact that COVID-19 has had on residents, the Rialto Rental Assistance Program will offer one-time utility assistance up to \$210 (\$70 per month) to help renters/homeowners in the City of Rialto. Financial assistance will be offered to moderate income households per Housing and Urban Development (HUD) guidelines who rent/own in the City and have experienced loss of income due to the COVID-19 pandemic. The grant program is made possible with federal Community Development Block Grant CARES Act (CDBG-CV) funds from the Department of Housing and Urban Development (HUD), therefore residents must meet all requirements to be eligible for the program. The program will conduct a lottery to select applicants to verify eligibility. **Payments will be made directly to the utility provider.**

**If you apply for Rialto Utility Assistance Program, you may not apply for the Rialto Rental/Mortgage Assistance Program.**
